27 WHEREAS, Sallie has successfully served as the chief labor negotiator for
28 the Borough, drafted and implemented numerous policies, and started programs such as
29 the Workforce Strategic Plan to provide employees with opportunities for advancement;

33 numerous additional tasks, such as serving as Chief of Staff, the Borough’s Public
34 Information Officer, and Co-Chair of the Media Committee for the Arctic Winter Games;

38 it with a positive attitude and ability to enjoy even the toughest challenges she
39 encountered here, and is viewed as a trusted advisor known for her dependability in

43 the Borough’s mission; ability to make excellent and timely decisions; willingness to be


44 at the forefront of her field; and ability to institute policies and changes for a healthy,
